Amount	\$2,000 to \$15,000 with 3% interest rate
Repayments	Fortnightly with terms of 2 to 10 years
Fees	<p>\$0 establishment fee</p> <p>\$0 weekly account keeping fee</p> <p>\$0 introducer fee</p> <p>\$4.99 late payment fee may be applied if you miss a repayment (late fees are capped at \$49.90/year)</p>

The ACT Sustainable Household Scheme is only accessible via accredited vendors enrolled in the Scheme. The funds provided through the Scheme are paid directly to your vendor by Brighte. You will then make repayments to Brighte in line with the terms of the loan.

For residential households

The Scheme offers loans for not-for-profit community organisations.

Home Energy Support Rebate (HESP) up to a maximum of \$5,000.
Eligible households can get two rebates of up to \$2,500 each — and access a 0% interest loan of up to \$10,000 to cover the rest.
